The purpose of the Medford Parks and Recreation Foundation is to enhance the quality of life for everyone in Medford. We accomplish this by cooperating with and seeking to implement the City of Medford Leisure Services Plan, which includes:

- Raising funds to support parks and recreation programs, facilities, and services
- Promoting the value and benefits of our city parks and recreation programs
- Providing opportunities for partnerships with other community organizations
- Supporting parks programs that educate our community, especially our youth

Projects & Programs

Play Every Day Scholarship Fund

Established in 2006, the Play Every Day Scholarship Fund provides opportunities for youth to attend recreational and enrichment programs offered by the Medford Parks & Recreation Department. Since its inception, this fund has provided \$97,200 in scholarship support for such programs as: day camps,

swimming lessons, and youth sports programming.

Funds are secured through the following events: Parks Uncorked, Beat of the Rogue, Lithia Open Tennis Tournament, and individual donations. Here is what a donation to this fund will provide:

- \$25 = One week of swim lessons
- \$50 = One week of an all-day camp program
- \$75 = A full year of recreational sports programs
- \$100 = Swimming lessons and a family season pass to the Jackson **Aquatic Center**

Past Projects

• 2007: Fichtner-Mainwaring **Park Tennis Court Expansion**

Through the generous efforts of the Tennis in the Park committee. over \$280.000 was raised in order to build four new tennis courts with lights. These courts have helped grow the sport of tennis in west Medford and have provided space for tennis lessons offered to both youth and adults.

Tennis at Fichtner-Mainwaring Park

• 2008: Summerfield Park

The Foundation played a large role in the development of this 1.8-acre park within the SE Area Plan. Through the donation of land by Mike and Lou Mahar, the Foundation was able to coordinate the first developer-built park in the Medford park system. This partnership saved the City nearly \$800,000 in land and development costs.

• 2009: Larson Creek Greenway

The Foundation received another land donation from Mike and Mary Mahar along the Larson Creek Greenway which will serve as a future pedestrian path from the Bear Creek Greenway to the SE Area Plan and beyond.

• 2012: Santo Community Center **Play Structure**

The installation of a new play structure at the Santo Community Center was completed just prior to summer

activities beginning in May 2012. This

new play structure was the result of private foundations and the Medford Kiwanis Club joining forces with the Foundation to create this new recreational space.

Park Facts

Parks are a tangible reflection of the quality of life in a community. They provide identity for citizens and are a major factor in the perception of quality of life in a given community. Parks and recreation services are often cited as one of the most important factors in surveys of how livable communities are.

Ways to Give

Cash Donations

Most gifts to the Medford Parks and Recreation Foundation take this form, and it is as easy as writing a check. Checks should be made payable to the Medford Parks and Recreation Foundation. You can also call 541-774-2400 and gift using a Visa or Master Card.

Gifts of Appreciated Property

With careful planning, charitable gifts of long-term appreciated securities or real estate can create very favorable tax benefits.

Bequests

Gifts via wills and bequests can provide you with an opportunity to honor and sustain your family name in conjunction with the Medford Parks and Recreation Foundation's name recognition program. The Medford Parks and Recreation Foundation will work with you and your attorney to provide the language necessary to ensure that your intentions are clearly expressed.

Life Income/Charitable Trusts

Charitable Trusts and charitable gift annuities offer an opportunity to make a substantial gift to the Medford Parks and Recreation Foundation without forfeiting the annual income produced.

Matching Gifts

Many companies will match your contribution to the Medford Parks and Recreation Foundation. Submit your company's matching gift form with your contribution and it can significantly increase your support and associated giving level.

Life Insurance

Many people own some form of life insurance, which can play a very important part in planned charitable giving. Life insurance for charitable purposes can be accomplished by 1) the transfer of ownership of an existing policy to the Medford Parks and Recreation Foundation, or 2) the purchase of life insurance which names the Medford Parks and Recreation Foundation as the beneficiary and/or owner.

Gifts-In-Kind

Gifts of good or services can be of great financial assistance to the Medford Parks and Recreation Foundation, while offering the donor a tax dedication for the fair market value of the gift.
